Sir,

This is to notify that your original price proposal submitted on 28.04.2010 regarding Six laning of Chilakaluripeta - Nellore Section of NH-5 from km 1182.802 to km 1366.547 (length-183.620 Km) in the State of Andhra Pradesh under NHDP Phase-V to be executed as BOT (Toll) Project on DBFOT Pattern for a grant of Rs. 126.99 Crores (Rupees One Hundred Twenty Six Crores and Ninety Nine Lacs only) is hereby accepted by NHAI, declaring you as the "**Selected Bidder**".

In accordance with the clause 3.3.5 (Volume - I) you are hereby requested to confirm your acceptance of this LOA within 7 days of its issue and return the duplicate copy of the LOA duly signed in acknowledgement thereof. Thereafter, you are required to execute the Concession Agreement within 30 days of your acceptance of LOA as per clause 1.3 (Volume-I).

3. Further as per RFP documents, you are required to incorporate a Special Purpose Vehicle solely for the purpose of domiciling the project (the "Concessionaire"). The Concessionaire for due and faithful performance of its obligations during the Construction Period shall furnish a Performance security by way of an irrevocable and unconditional Bank Guarantee of **Rs.130.31 Crores (Rupees One Hundred Thirty Crores and Thirty One Lacs only)** within the period expiring on the 180th day from the date of signing of the Concession Agreement. Till the time the Concessionaire provides NHAI with the Performance Security, the Bid Security shall remain in full force and effect (refer Clause 4.1.2 and Article-9 of RFP - Vol- II).

4. You are required to comply to all the terms and conditions as set forth in the RFQ, RFP documents and subsequent addendums/corrigendums issued.
